Ayuda Legal created and developed new educational content at Ayudalegalpr.org. This is a platform owned and administered by the organization that provides free and accessible legal education to nearly 1.5 million people per year. The support received this year permitted enabling live help systems that let us provide free legal support to people through the internet. This webpage has fostered the sustained collaboration between all of the free legal service providers in Puerto Rico and law school students. Ayuda Legal provided nearly 100 workshops in over 60 communities around the island, offering legal education workshops around the Island on issues around access to justice, right to safe housing and displacements. Ayuda Legal advocated successfully for FEMA to accept a sworn statement, developed by the organization. This may have potentially impacted nearly 77,000 whose applications were denied because they lacked formal title deeds. The sworn statement represented an alternative proof of title that could permit access to funds for eligible participants. Ayuda Legal Puerto Rico trained nearly 350 lawyers and students on issues related to disaster relief legal aid.
